The purpose of this guide is to show our NIV mask range with examples of breathing systems and accessories that can be used with each type of mask. Always refer to the user guide supplied with your NIV device for the specific set-up required.

Vented NIV masks with an anti-asphyxiation valve

Vented masks have integrated holes or leak ports in the mask to remove exhaled CO₂. Vented masks can also be referred to as ported masks or masks with CO₂ leak port. These masks have an anti-asphyxiation valve that opens in the case of an unexpected ventilator failure, or breathing system disconnection, allowing the patient to breathe spontaneously from the atmosphere.

The masks shown on this page are vented masks, with an anti-asphyxiation valve. This type of mask can be used with single limb breathing systems which do not have a built-in CO₂ leak port.

Examples of Intersurgical breathing systems that are appropriate for use with this type of mask are shown on page 3, opposite together with filter accessories that may be required.










Non vented NIV masks with an anti-asphyxiation valve

Non vented NIV masks with an anti-asphyxiation valve do not have integrated leak ports and can be used with single limb breathing systems which have a CO₂ leak port. The CO₂ leak port in the breathing system removes CO₂ during the exhalation phase.

These masks have an anti-asphyxiation valve that opens in the case of an unexpected ventilator failure, or breathing system disconnection, allowing the patient to breathe spontaneously from the atmosphere.

Examples of Intersurgical breathing systems that are appropriate for use with this type of mask are shown on page 5, opposite together with filter accessories that may be required.








Flextube breathing systems for passive humidification

Flextube breathing systems for active humidification




